

# **Women's Council of Realtors Annual Professional Development Scholarships**

## **Purpose**

This scholarship program, funded annually in the amount of \$1,000.00 by the WCR, was initiated to assist the professional development of WCR Realtor Members. The scholarship program is intended to assist recipients in improving their skills and abilities to better serve the buying and selling public, by providing funds to them to attend professional development courses sponsored by the Women's Council of Realtors, Dayton Area Board of Realtors, Ohio Association of Realtors, or National Association of Realtors.

## **Qualifications**

To be considered for receiving the scholarship, the applicant must have been an active real estate licensee and a WCR member of the Dayton Chapter for at least one full year as of the date of application. Applicants must also complete the prescribed application form and submit it no later than August 31<sup>st</sup> to be considered for the 2006 scholarship. The scholarship may be applied to any class that you have taken or will take between January 1<sup>st</sup> and December 31<sup>st</sup> of the 2006 award year. You may be a recipient of this scholarship no more than once every three years.

## **Procedures**

1. Applications shall be submitted only on an official application form of the WCR. The application form is available from [www.wcrdayton.org](http://www.wcrdayton.org). Applications will be taken at any time on or before August 31st, for consideration for the 2006 scholarship.
2. Up to 4 scholarships of \$250.00 will be awarded. Scholarship awards will be in the form of a credit held in the recipients name and can only be applied to registration fees for WCR, DABR, OAR, or NAR professional development courses. Scholarship will be awarded upon receipt of proof of course attendance.
3. The three members of the WCR Scholarship Award Committee will be comprised of the President, President-Elect, and one affiliate member appointed by the President. Any applicant who may be related to an awards committee member in any way by family relationship or business association is automatically ineligible.
4. Recipients are notified in writing within ten (10) days of completion of the selection process. If a recipient declines the grant, the next qualified candidate may be eligible to receive the grant.
5. The scholarship award amount is only available for the year of the award. Any unused amount of the award will no longer be available for the recipient's use and will remain in the WCR Professional Development Scholarship Fund.
