**Tenant Enrollment Agreement**

1. Complete, sign, and date this Agreement. Keep a copy for your records.
2. **Place your blank, voided permanent check (with your name pre-printed on it) at the top of this form or on a separate page.** If you do not have permanent checks or to debit a savings account or reloadable prepaid debit card, submit official bank documentation that is typed by your bank and confirms (a) your name, (b) bank routing number, (c) bank account number, and (d) type of account (checking or savings). To debit a business account, submit this letter plus (e) business name and (f) authority to sign on the account.
3. Give these materials to your property manager/landlord, **fax them to ClearNow at (919) 680-4700, scan and e-mail them to Support@ClearNow.com, or mail them to ClearNow, Inc., PO Box 266, Durham, NC 27702.** Pay rent as usual until you receive your enrollment confirmation.

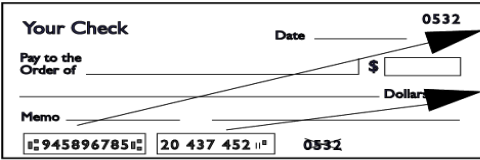

- I acknowledge that debits to my bank account must comply with US law.
